PRESIDENT'S UPDATE

Dr. Dominguez reported on the following:

- 1. The Technical Assistance Visit is scheduled for September 14, 2000, beginning at 1:00 P.M., in Room 2131. At 6:45 P.M., a dinner is planned with David Viar, Executive Director for the Community College League California and Linda Collins, Statewide Academic Senate President. The topic for discussion is "Shared Governance".
- 2. The 2001-2002 California Community Colleges Budget Proposal requests \$735 million, which includes a \$400 million increase in revenues for FTES, and \$45 million for equalization, which is now being called Ensuring Student Success Statewide, and \$152 million for growth.
- 3. Kudos to Mary Kay Borchard and IVC's Reserve Officer Training Program for the feature story which appeared in Imperial Valley Press on September 5, 2000, touting the fact that our program gives

many future police officers the inside track on what it means to be a law enforcement officer before entering a full police academy.

4. Spectrum Advertising of El Centro has extended an invitation to the Imperial Valley College community, in the spirit of international relationships, for up to 25 members of the student body, faculty, staff, administration, and Board to tour historical, industrial, and educational Mexicali on Friday, November 3, 2000, from 8:00 A.M. until 12:00 P.M. noon. Announcements explaining the details will follow.

UPWARD BOUND PROGRAM

Rosalie Lopez, Director of the Upward Bound Program, presented a Power-Point presentation on the upcoming April 18-23, 2001, New York City Study Tour and the Summer Residential Program held at the University of California, San Diego.

The Educational and Cultural Study Tour will 40-45 high school students from throughout the Imperial Valley to experience New York City. The trips master schedule was distributed, and students will experience a campus tour and presentation of Columbia University, United Nations, World Trade Center, and the Statue of Liberty, and students attended two Broadway performances and toured Manhattan. Each student raised \$750.00 through a variety of community fund-raising activities.

The 2000 Summer Residential Program at the University of California, San Diego, motivates high school students by allowing them to experience the residential collegiate environment, earned 10 high school credits, improved their career awareness, and gained confidence in personal development.

2000-2001 BUDGET/DISTRICT RESERVES

Carlos Fletes reported that the budget is balanced and has been developed by the IVC Budget and Planning Committee in coordination with the Superintendent/President and the Business Services Office. The total projected income for 2000-2001 is \$34,810,077.26, which does not include growth in enrollment, but does include COLA of 4.17% or \$476,105, Partnership for Excellence funding of \$747,587, Instructional Equipment Grant of \$18,666, and Block Grant for \$439,062. The total budgeted expenditures for 2000-2001 are projected at \$32,847,524.22. The reserves include the Board Reserve of \$1,300,000, restricted program reserve of \$455,893, and unrestricted reserves of \$206,660, which totals \$1,962,553.
