DISCUSSION ITEMS

A. Moving Soil

P. Pauley spoke with Jimmy Sanders regarding allocation of soil.

Love would like to see schools outside the valley participate. E. Hale asked if college carried liability insurance coverage. P. Pauley will check on that. One concern P.
