AREA REPORTS/UPDATES

College Council Report

Chair Michael Heumann reported the following:

Reported that he and Academic Senate President Kevin White both met with the
Accreditation team and noted that the interviews went well. He stated that the team
made a comment that at other community colleges it was common that the College
Council function as the Strategic Planning Committee.

Program Review

Vice President for Academic Services Kathy Berry reported the following.

 Reported that Program Review was almost complete and by next year the District will have completed the three year planning cycle.

Budget Update

Vice President for Business Services John Lau reported the following:

 Announced that he is looking to make the budget process more efficient and effective and would begin by meeting with the VPs and department managers in the coming weeks.

ASG President Update

Associate Student Government President was not present at the meeting. Student Representative Brian Phillips reported the following:

- ASG participated in the Relay for Life in April and stated the event went well.
- On May 3rd and 4th ASG would be having election of officers, and indicated there were ten candidates who passed the screening committee.

President Update

President Ed Gould apologized for being late and stated he was at an Imperial County School Voluntary Employee's Benefits Association (IVSVEBA) board meeting in the hopes to gain membership.

Accreditation

• He reported that preliminary finding were very positive on SLO.

- The team liked the new budgeting plan for 2010-11.
- They were impressed with the Technology Plan and liked that it was linked to the Education Master Plan and Strategic Plan.
- Recognized that Program Review has improved and is linked to the budget.
- The team recognized the planning processes were thorough but a bit clumsy; and recommended a graphic representation of the planning process be made, and that every plan should identify the Education Master Plan or Strategic Plan goals and objectives that it is addressing.
- Report would be written to remove IVC from Warning Status but there are no guarantees.

AB37 Honorary Degrees

- Announced that this is a law required by the Board of Governors of the California Community Colleges and the District would be recognizing individuals who were forced to leave his or her postsecondary studies as a result of federal Executive Order 9066 which caused the incarceration of individuals of Japanese ancestry during World War II.
- Announced there are four individual that the District was able to identify: Terry Koike, Hiroshi Kaku, Emiko Kaku, and Sachiko Kaku Cole.
- Announced that these individuals or their relatives would be given Honorary Degrees at this year's graduation.

Replacement and Title of the Chief Technology Officer

• He reported that the Dean of Technology position would be filled and the titled changed to Chief Technology Officer.

American Association of Community Colleges Report

He reported that he attended the AACC convention in Seattle April 18-20th, and there
was discussion regarding funding possibilities, book rental programs, and the impact of
online education.

The Follett Rental Program and Supporting Students without Credit Cards

 Announced IVC would be going on board with the Follett Rental Program, and stated the criteria is that a credit card would be required. There was discussion about some students not wanting to use a credit card, and the District having to shoulder some of the risk.

Focus on Developmental Education

 The Gate Foundation is funding improvements in Developmental Education and lowering the cost of books.

Accountability and SLO's are Here to Stay - How Do We Want to be Measured

- Student Learning Outcomes are here to stay.
- o Community Colleges must change their Completion Rates because they are the "on-ramp" to higher education.

 California is looking at a standardize assessment in curriculum across the board as it relates to accountability.

The Applied Baccalaureate Degree Momentum

 The Lumena organization is supporting the applied baccalaureate in community colleges, particularly Allied Health and Renewable Energy.

Earthquake Aftermath

 He stated that the damage to the college was minimal and discussed the minor damages that occurred. He thanked the facilities crew and stated that they did an outstanding job in getting the college ready through spring break.

Gym becomes a Shelter

He reported the gym became a shelter on April 17th for people displaced after the April 4th earthquake. He reported the Red Cross notified IVC that the gym would need to be used as a secondary shelter for earthquake victims. He reported the displaced gym classes would continue in other locations for the next two weeks.

Bomb Scar

- President Gould stated that the bomb threat was well thought out and it began with a
 phone call. He reported the campus was then evacuated and the bomb squad and dogs
 arrived on campus. He stated it took four hours to search the entire campus and two
 packages were destroyed.
- He reported there was a primary briefing held on April 17th, followed by a formal briefing with the emergency response groups on April 22nd.
- Thanked all faculty and staff who helped with the evacuation, he indicated that they
 formed teams and went throughout the whole campus to help with the evacuation.

Southern California Association of Governments' Compass Blueprint Award for Visionary Planning for Prosperity

President Gould reported that the College received an award from the Southern California Association of Government (SCAG) which focuses on mobility, prosperity and sustainability. He stated IVC has been selected to receive the Compass Blueprint Recognition Award for Visionary Planning for Prosperity. He announced the award would be presented on May 5th at the SCAG General Assembly Dinner in La Quinta, CA.

Imperial Valley College Language Emersion Center Progress in Washington, D.C.

 He reported that Congressman Filner has sent a \$1.6 million request proposal to House Appropriation Committee for Funds for the Improvement for Postsecondary Education (FIPSE); and Senator Boxer has submitted the District's project to the Senate Appropriation Committee as a Workforce Skills Preparation Program for \$800,000.00.

Legislation of Interest in California and Washington

He reviewed the legislation and funding with the Department of Labor, Financial Aid, Institutional Aid, Title III, National Science Foundation (NSF), Workforce Investment Act Reauthorization, DREAM Act Development Relief and Education of Alien Minors, Community College Sustainability, Temporary Assistance for Needy Families (TANF), Elementary and Secondary Act Reauthorization and the National Endowment for the Humanities Challenge Grant Initiative for 2-Year Colleges.

Academic Senate - Kevin White

- Reported the Academic Senate voted for the changes to the dean committee.
- There was discussion about prioritizing the last three meetings.

Environmental Health & Safety Committee - Ted Ceasar

Ted Ceasar reported that there was discussion on the elevator issue. He reported there
was discussion on looking into purchasing an elevator chairs and other options were
discussed.

Policy & Procedure Committee - Victor Jaime

Reported the committee would be meeting on Wednesday April 29th.

Student Affairs Committee - Sergio Lopez

• Reported the committee is meeting this week to approve Associate Student Government's recommendations.

Budget and Fiscal Planning Committee - Kevin White

 Reported that an Adhoc Committee was created and its purpose is to get the committee moving in the right direction.

Facilities and Environmental Improvement Committee - John Lau

 Reported there would be construction in the summer and he would be sending out a four to six month build-out plan to let the campus community know what would transpire over the next six month.

Marketing Committee - Bill Gay

- The committee met on Thursday, April 22nd and discussed implementation of an electronic class schedule; developing consistent public design on all publication of the college; taking on the responsibility of school tours and developing a process; and discussed crisis communication.
- Chair Heumann asked for a demonstration of the interactive electronic schedule.

Professional Development Committee - Travis Gregory

DISCUSSION AND INFORMATION ITEMS

1. Naming of the Art Gallery - Michael Heumann

- Chair Heumann gave some background information on this item and stated this item was discussed and tabled at the September 22, 2008 meeting and returned to the Campus Ops Committee for further recommendations.
- Adjunct Instructor Armando Mendez spoke and stated there have been other
 developments since the original proposal for the naming of the Art Gallery was made.
 He acknowledged the need to recognize both Juanita Salazar Lowe and Domingo O.
 Ulloa. He indicated he would like to modify his original proposal based on the naming
 criteria and board policy as follows:
 - He proposed that the Art Gallery in the Science Building be named after Juanita Salazar Lowe; and the new Art Gallery be named after Domingo O. Ulloa.
- Adjunct Instructor Mendez noted that Domingo O. Ulloa was named the Father of Chicano Art by state legislature and would bring recognition and prestige to the college on a regional and international level; and Juanita Salazar Lowe would bring recognition locally for her contribution to IVC.
- Chair Heumann stated that these proposals would be brought back to be voted on at the next meeting.
- President Gould stated if it was named after Domingo O. Ulloa this would be the first time that it is named by someone that has had no direct connection to the college so you can see the passion of the community. He stated it is not an easy decision to make and he most likely would not make a recommendation to the Board of Trustee. He stated there is no precedent of naming a building after someone that is not associated with Imperial Valley College.
- He stated that the county had issues on the naming of the Pavilion and the District would have to follow their guidelines.

2. IVC employee survey results - Michael Heumann

- He announced the Employee Survey was conducted and results are in. He stated he
 would be sending out the survey with the results by email.
