I. Call to order

The way it works is, the instructor chooses the book, and the students choose their own format and price. They sell print-it-yourself, audio and soft-cover versions. a) **Dean Brian McNeece**

Brian reported that Kathy Berry told the Instructional Deans that Summer session 2011 will be limited to 240 FTES total. The Counselors looked at our lists with emphasis on transfer level classes. They cut out ESL and slashed Business classes and added more Math classes.

Brian mentioned that if IVC is an adjunct faculty members only place of employment, they would be given certain priority for fall class selection.

VII. Discussion

a) **Summer Session and Fall Scheduling**

We're still waiting to hear the final decision for summer.

For the Fall schedule we have to come up with two schedules to assess, one with a 10% cut and another one with a 16% cut.

b) Comprehensive Program Review of English Transfer and Journalism—Update

Michael discussed the completion of the CPR for English Transfer classes and for Journalism. He discussed the goals for the next three years for English Transfer. He discussed the possibility of doing specific CPRs for Reading, Writing, and Literature in the future.

c) Basic Skills Re-sequencing Committees Update

Michael shared with the division that on March 25th, him, Brian, Frank, Deirdre and Kathleen went to a workshop at Miramar College titled *Bringing Acceleration to English and Math to Your Campus*. They learned how other colleges are accelerating their programs.

The more students that have to take basic skills classes, the lower the number of students that get to transfer level.

Michael distributed copies of the course outline for Engl 010 – English Composition—Accelerated. It's a pilot program. Nancy asked if it would be exclusively for writing, Michael said no but that we might just start with writing for now.

He wants the division to read the course outline and give him feedback on it. He asked that they take a look at the objectives he listed. Most of these objectives listed do not require money; we can do these things within our own department.

d) Research Class

Robert gave Michael information on a class from Pasadena. It was a one-unit research class. Students would get specific training on how to do things in their major area. Michael will talk to other chairs to linking this class to some of their classes/majors.
