**PUBLIC COMMENTS**Ms. Madrid gave a handout in regards to online parking permit

Ms. Madrid stated that students will still be able to purchase semester parking permits at the Campus Safety and Parking Control Office if they wish. The \$3.00 shipping and handling fee will only

be added if a student orders online.

Senator Torres inquired in regards to a fiscal impact of the new

system toward the college. Ms. Madrid stated that there would not be a fee toward the college. The only money that the company would make would be the \$3.00 shipping and handling fee.

The ASG will vote on endorsing the program at the next ASG meeting.

Senator Gallegos attended the Academic Senate last week where they went over an extensive survey that will be given out to instructors on campus having to do with Administrator evaluations, instructor statistics, and student learning outcomes. This survey ties in with the college's accreditation.

President Trejo announced that he attended the Board Meeting last Wednesday and it was announced that the extended campus in Calexico will be closing.

President Trejo went on to inform the senate that morning classes will be held at the SDSU Calexico campus and evening classes will be held at the Calexico High School. This will be at no-cost to the college. The college will try to maintain as many services as possible to the students that where utilizing the Calexico extended campus.

Advisor Lopez added that the College will be saving over \$100,000 in closing the extended campus in fees for the lease. There will be many upgrades coming with the utilization of the new venues for the college courses.

President Trejo went on to add that at the board meeting, SLO (Student Learning Outcomes) and SLA have also improved.

Another issue that was raised at the board meeting with student was the "first-step" program that will be continued. The program assists with first time freshman with registration and becoming interested in college events.

Advisor Lopez continued on with the "first-step" program and the benefits of the program. The ASG will be in talks during the summer in assisting with the program.

Advisor Lopez went on to add that the registration needs to be balanced between new incoming students and those that need classes to graduate or transfer.

Advisor Lopez went on to inform the senate of a new policy that will be going into effect of students that will be dropped from the college for lack of progress. This upcoming fall, the college is looking at losing approximately 500 students due to lack of progress. He added that there is an appeal process that students can follow to be admitted back into the college.

The meeting was adjourned at 2:08 p.m.
