She also stated that the set up for inside and outside had been submitted on Friday, October 2nd. She also stated that the supplies for the BBQ had been purchased and the only thing pending was the purchase of propane. Mr. Lopez volunteered to purchase the propane for tomorrow's event. Mr. Lopez stated that eight agencies will be present during tomorrow's event.

M/S/C (Myra Martinez/Libertad Cabrera) to approve the Health Fair expenditures not to exceed \$1,200

Discussion: Mr. Lopez stated that for future reference Senators should provide a list of all the expenses for the Senate to review.

Mr. Lopez stated that in the past the ASG has sponsored a kickoff BBQ during the first Men's & Women's Basketball game. He stated that the ASG should sponsor such event every fall. Therefore, the item will be placed on Monday's agenda for approval of BBQ expenses and the pocket schedules.

Crystelle Enriquez stated that she had created two different posters for the Health Fair. Flyers were posted last week in all posting areas. She also stated that flyers were distributed inside the College Center to each student and stacks of flyers were distributed to different departments. She will begin working on publicizing the IVC Idol activity.

President Sciaky stated that publicity for the Town Hall meeting scheduled for this Wednesday, October 7th in the College Center needs to be posted as soon as possible. President Sciaky will be the MC (master of ceremonies) for the event.

M/S/C (Libertad Cabrera/Carolina Godoy) to approve \$1,166 for the purchase of a new ASG Canopy.

Discussion: Mr. Lopez stated that last year the college was going to put a shade structure in the bus stop but due to the delay in delivery and the inspection of such the canopy was placed over by the Swimming Pool area. Construction for a shade structure in the bus stop was supposed to be done last summer has also been delayed. During the first Town Hall meeting this semester students requested a shade at the bus stop. Mr. Lopez was asked by the college to temporarily place an ASG tent at the bus stop area until construction in that area is done. He also stated that the President's office is willing to pay for half of the canopy's expense. The ASG will pay the other ½ for a new shade of \$1,166.00. The old canopy is currently at the bus stop and at the end the ASG will end up with two canopies at half the cost. President Sciaky stated that students have been appreciated for the temporary canopy at the bus stop.

M/S/C (Myra Martinez/Ashley Juarez) to approve the purchase of the poster water base paint kit in the amount of \$500

President Sciaky stated that the colors are: black, red, blue, green, orange, brown, yellow, and purple. Price for a set \$466.99 and the paints will be used for publicity for ASG and Club events.
