Academic Calendar	Ms. Gaylla Finnell handed copies of the proposed Academic Calendars to the ASG Senate. She stated that the State finally approved and signed the budget which is good news for all community colleges. She stated that there has been a 2.2 % growth that will benefit all colleges. The Academic Calendar strongly affects faculty. The calendars have been presented to the Academic Senate and a subcommittee has been formed to discuss and put together different options of the calendar. The subcommittee is now asking for student's input and is requesting at least two (2) ASG representatives to be part of the Academic Calendar Subcommittee. After Ms. Finnell explained the options of the calendars for 2011-2012 and 2012-2013 she stated that they are not a done deal until it goes to the Negotiation Committee. She stated that this is the first time that she has			

everyone collaborate in such project because she believes everyone's input is extremely important. The Academic Senate will be discussing the options at their next meeting scheduled for Wednesday, October 20th at 1:30 p.m. in the Administration Board Room. She would like for the ASG to be prepared and join the discussion on this item. The deadline to submit the calendars to the Chancellor's office is January 2011. The deadline also impacts Financial Aid and that is important for students. The goal is to submit at least two years but the subcommittee wants to go as far as four years. Please keep in mind that this is a work-in-progress and changes are still being made. Version 2 of the 2011-2012 includes Winter Intersession where version 1 includes two summer sessions. As most students are now aware Winter Intersession was cut due to the current budget crisis. Since the calendar cannot be moved up now that winter has been cancelled the college will now have a six-week 'dead time' from January 6th through February 8th. Ms. Finnell stated that the college is still in a budget crisis. IVC keeps getting short loans to pay out salaries, bills, etc. She stated that there is money that has been promised but the college does not have it yet and meanwhile we are all suffering. Ms. Finnell explained how summer's FTE's are accounted differently than winter. She stated that summer gives flexibility when it comes down to counting FTE's. The Administration has decided not to offer winter but instead will offer two summer sessions. She stated that the first summer session will only help college students since the start date will be May 14, 2012 and most high school students will not be able to take advantage of this particular session. The second summer session will begin June 25 and this will benefit those students right out of high school. Another item discussed was the 2012 Spring Break. Mr. Lopez mentioned that in the past, IVC has kept the spring break in line with the K-12 schools. Ms. Finnell stated that IVC has kept in line to accommodate our students, staff and faculty but that most colleges and universities do not line up Spring Break with the K-12 calendar. Therefore, version 1states having Spring break from March 5 through March 9 while the K-12 will be from April 9 through April 13, 2012. Ms. Finnell again emphasized the importance of having student representation at the next Academic Senate Meeting scheduled for Wednesday, October 20th at 1:30 p.m. in the Administration Board Room. The Academic Calendar Subcommittee will be meeting right after that meeting at 3:00 p.m. in room 303.
