Cultural

Ryan Pimble stated that during the CCCSAA conference this weekend he met with a representative from Riverside Community College. The representative told Ryan that they had Tolerance Week in the month of November. Each day include the following: Breast Cancer Day, Black Day, Rape Day, and Killed by Drunk Driver Day. Ryan also stated that the ASG should also implement Tolerance Week in the month of November.

President Mendenhall asked Ryan Pimble and Jade Zoghbi to contact the local High Schools to inquire which would be interested in participating in the event for "Music in our Community" activity that will take place in the month of March. Mr. Lopez stated that it would be best to also contact the music department and check to see if they also want to participate. A meeting will be scheduled with President Mendenhall, Mr. Lopez, and Van Decker to discuss details of the event.

President Mendenhall asked Richard Webster and Leroy Lopez to finish the posters for the Halloween Carnival that will be held on Thursday, October 30<sup>th</sup> outside the College Center. Richard will also add on the ASG marquee the Halloween Carnival and the Volleyball game that will be held on October 22<sup>nd</sup>.

President Mendenhall stated that the Smoking Policy options will be placed in the Senator's mailbox. One of the options is to have all of the parking lots as designated smoking areas with the exception of parking lot A because it is next to the Preschool.

Jonathan Balint stated that during the CCCSAA conference he realized that the majority of colleges had or have issues in implementing the smoke free campus. One of the major issues is that some colleges notice the lack of enrollment. He stated that other colleges have designated areas for smokers and feels that this would be a better option for our campus. Enforcing and signage seems to be a problem at IVC. Therefore, his suggestion is to educate staff and students and provide larger signs in a visible area.

Mr. Lopez agrees that there is a lack of enforcement on the smoking policy. However, once a policy is adopted the Associate Dean of Human Resources will be responsible in enforcing the policy to our Faculty and Staff. Mr. Lopez will be enforcing the policy on students. Mr. Lopez also stated that second hand smoke affects others and it is a health issue. The policy will be viewed by Academic Senate and CSEA. President Mendenhall suggests that the different policy options be
