IVC Superstore – Omar Ramos

IVC Student, Omar Ramos gave a presentation on how an IVC Superstore will benefit the Associated Student Government and students. The IVC Superstore is an on-line resource similar to eBay or Amazon.com. Omar stated that individuals purchasing off from Amazon like ordering from the site because they are exempt of sales tax. Omar stated that sales taxes are included in the purchase and that "our local government actually loses money when you go and buy online at Amazon.com."

Omar's idea of the IVC Superstore "is to allow a group of people, in this case the Imperial Valley College student population, to raise money from online purchases that would have occurred anyway (except no money would have been coming back)." The IVC Superstore will be part of the Amazon Associates Program and eBay Affiliates program website. Students will not only be allowed to purchase books but may also be able to purchase movie tickets, songs, tools, jewelry, etc.

Omar explained how the revenue will work depending on how much purchases are made on the IVC Superstore. Omar stated that each item purchased is counted instead of per purchase making it easier to gain revenue. Omar's offer is that his "idea

be 'licensed' to the school at the rate of 2% of the revenues generated per month." Omar met with Dr. Ying, Dean of Technology & Learning Services and Dr. Ying's only concern was the on campus bookstore. Mr. Lopez reminded Senators that the ASG will bid to purchase the bookstore which is something that needs to be taken into consideration.

Tony Ojeda thanked Omar for a "terrific" idea and agrees that such a website will really benefit IVC students; Mr. Lopez agreed.

Mr. Lopez and President Lopez also thanked Omar for his time and presentation. Mr. Lopez stated that the item will be presented to the ASG Finance that Sammy Felix chairs. Once the Finance makes a decision to move forward with the IVC Superstore then it will be taken to the other shared governance committees, such as College Council. More information will be released as soon as it becomes available.
