Course Description and Introduction: There are two main objectives for this course. The first is to introduce you to the kinds of issues addressed in the area of philosophy called Ethics and to encourage independent reflection on them. The second is to address specific questions and the answers given by historical and contemporary philosophers concerning the following questions and theories: What is Ethics? Does ethics require God? Is ethics relative or objective? Why should one be moral? What is the nature of ethical value? We will explore Utilitarianism, Kantian ethics/deontological systems, Contractarianism, and Virtue ethics.

Required Texts: Ethical Theory: Classical and Contemporary Readings, 5th Edition. By Louis P. Pojman

Course Requirements: Final grades will be determined by class participation, quizzes, a short paper, and four exams, including a final exam, as outlined below:

Writing assignments will be due at the beginning of class. They will be graded by letters ranging from an A to an F.

There will be four exams throughout the semester, two smaller exams and a comprehensive final. Before each exam I will tell you what kinds of topics will be on the test so you can prepare accordingly. Scantrons are need, the form is 882-E.

In addition to the Paper and exams, there will be 4 <u>pop</u> quizzes, each is worth 2.5% of your final grade. There will also be a short paper (4-6 pages) assigned near the end of the semester. The specifics of the paper will be covered in class.

Finally, a significant component of your final grade will be based on your participation in class. To do well in the class, you should attend class meetings on a regular basis. Also, you can participate by raising interesting questions and comments in class. Please make sure cell phones and any other electronic device are turned off while you are in class!

Plagiarism: We'll talk about plagiarism on the first day of class so that everyone will know what exactly it is. Plagiarism means attempting to give the reader the idea that words or ideas in an essay are your own when in fact they are someone else's.
