2010-11 State Budget Update

John Lau reported that the state has not yet adopted a budget. The District is not receiving apportionment payments and has issued Tax Revenue Anticipation Notes to meet its cash needs through the end of October. Districts have until October 15 to adopt their final budgets, and IVC will be holding a special board meeting on October 14 for final budget adoption.

The committee questioned whether the overall re-organization was cost neutral and asked for the final cost of the re-organization for the next meeting. It was noted that the administrative assistant position for IT was not included in Program Review and that the committee had recommended against replacing the VP for Information Technology. A sub-committee (Kevin White, Yethel Alonso and Michael Heumann) was formed to draft a recommendation to the President.

John Lau commended both union groups for working with the District toward budget solutions. Negotiations are still on-going with CSEA.

Marilyn Boyle asked about savings from the new insurance plan; John Lau responded that one year of activity is needed in order to determine the actual cost.

Carlos Fletes stated that his recommendation is that the committee support a balanced budget. John Lau stated that the budget was developed using the best estimates available for revenue and expenses, but placeholders were needed because negotiations were not finalized. It is not possible to develop a budget having perfect knowledge of all factors. Mr. Lau further stated that the District will not be able to use reserves to balance the budget in the future.
