# I. THE MEETING WAS CALLED TO ORDER BY JOSE LOPEZ AT 3:35 PM.

II. <u>WELCOME</u> All in attendance were welcomed

### III. <u>APPROVAL OF OCTOBER 5, 2009 MINUTES</u> The minutes were unanimously approved

## IV. PROGRAM REVIEW DEADLINE

Efrain Silva informed the membership that the program review deadline is approaching soon. The budgets are due October 26, 2009. Mr. Silva has created a binder for Frank Miranda and Jose Velasquez to refer to during the program review process.

## V. CERTIFICATION FOR INDUSTRIAL TECHNOLOGY PROGRAMS

Efrain Silva informed the membership that all Industrial Technology programs are expected to be certified. He stated that there will be a timeline. Programs that are not certified will be terminated. Efrain asked the faculty what type of certification is available in their discipline. The instructors responded the following:

- <u>Automotive</u>: Jose Lopez and Ricardo Pradis responded that NATEF (National Automotive Technicians Education Foundation) is the main organization that certifies qualifying programs and is recognized by the automotive industry.
- <u>HVAC:</u> Frank Miranda stated that he is currently working with NATE (Northern American Technician Excellence) on the certification process.
- <u>Building Construction</u>: Jose Velasquez stated that there are several options available. One of the options that was considered last year would have added additional student fees and was not pursued.
- <u>Welding</u>: Marco Morales responded that he is currently working with AWS (American Welding Society) to update some information.

# VI. SHOP SAFETY ISSUES

Efrain Silva announced that he observed that some students were not wearing safety glasses. Mr. Silva emphasized that it's important for students to use them. He also requested that all faculty enforce safety rules.

## VII. HOUSEKEEPING

Efrain Silva announced that Asbury Environmental would be coming monthly to pick up hazardous materials. Mr. Silva asked instructors to observe hazardous materials. Mr. Silva also asked that equipment that is not being used be disposed or donated.
