

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding shall stand as evidence that *(Name of District)* Imperial Community College District intends to work together toward the mutual goal of collaborating to form a consortium to improve the delivery of adult education. - Pursuant to E.C. 84905, each consortium member representative will need to be approved by the member's district governing board. The critical factor is that the governing board of the district needs to know who is representing their district at the consortium.
- Will serve as a contributing member of the Imperial County Adult Education Consortium and provide data and information relevant to adult education for the AB 104 Adult Education Block Grant.

This Memorandum of Understanding is in force from July 1, 2015 to June 30, 2016 and is renewable thereafter or may be terminated by either party in thirty (30) days by giving written notice of the intention to terminate agreement.
