✓ ARTICLE IV - Page iii, Second paragraph

No student shall hold the office of President who has not completed at least six (6) units of course work, and has served at least one term on the senate at Imperial Valley College at the time of the presidential election. The Candidate must have also and who has not been in residence at Imperial Valley College for two semesters as a regular member of the Association (including the semester in which the presidential election is held).

- (c) Online voting shall begin at 12 am on the first day of voting and close at 3pm on the second day of voting Polls shall be open from 8:45 a.m. to 4:00 p.m. and from 6:30 p.m. to 9:00 p.m. on the first day of voting and from 8:45 a.m. to 2:00 p.m. on the second day.
- (d) No campaigning may take place within 50 feet of the polls.
- (h) Defeated candidates shall have ten (10) school days from the announcement of the winner(s) to contest the election results. *Results of the voting* Ballots may not be *deleted* destroyed within this ten school day period.

 Section IV. Rules Pertaining to Ballot Counting letter "b" through "e"
- (b) Immediately following the closing of the online voting polls in the Presidential, Senate and other major elections, the results will be validated and presented to the elections officer by the Information Technology department. a ballot count will take place in a predetermined room on campus. The Elections Committee, with the Elections Officer presiding, and not less than ten (10) counters must be present for the count.
- (c) Once the count has started, no counter may leave the room until the count has been completed.
- (d) Each candidate may have one representative present during the count as an observer. They may not take an active part in the ballot counting and shall abide by all rules concerning ballot counting.
- (e) The validity of all ballots will be determined by the Election Officer.
- ✓ PLEBISCITE CODE OF 1974 Page 26 General Provisions – letter "b", "c" and "g"
- (b) Online voting shall begin at 12 am on the first day of voting and close at 3pm on the second day of voting. Polls shall be open from 8:45 a.m. to 4:00 p.m. and from 6:30 p.m. to 9:00 p.m. on the first day of voting and from 8:45 a.m. to 2:00 p.m. on the second day.
- (c) No campaigning may take place within 50 feet of the polls.
- (g) Candidates shall have ten school days from the announcement of returns to contest the election results. *Results of the voting Ballots* may not be *deleted destroyed* within this ten school day period.

✓ Page 27 - Instructions to Voters

To vote, *click on your selections* place a cross (+) in the voting square next to your selection. Where two or more choices for the same item are to be selected, *click* place a cross (+) next to the choices for which you desire to vote, not to exceed, however, the total number of choices to be selected.

All other marks or erasures are forbidden and make the ballot void.

If you wrongly mark, tear or deface this ballot return it to the inspector of election and obtain another.

- ✓ Page 27 Instructions to Voters Section II - RULES PERTAINING TO BALLOT COUNTING, letter "b", "c" and "d"
- (b) Immediately following the closing of the online polls voting, the results will be validated and presented to the elections officer by the Information Technology department. a ballot count will take place in a predetermined room on campus. The Elections Committee, with the Elections Officer presiding, and not less than ten (10) counters must be present for the count.
- (c) Once the count has started, no counter may leave the room until the count has been completed.
- (d) The validity of all ballots will be determined by the *Information Technology Department*, Elections Committee, and/or Elections Officer.
