Goals 2017-2018

At 1:25 p.m., Director of Maintenance and Operations, Mr. Rick Webster reminded Senators that the 2700 building is a "No Food, No Drink" building. The reason for this policy is because the building is all carpeted making it extremely difficult to remove syrup stains, etc. Unfortunately, there is currently no enforcement of this rule because the college does not have the manpower to do so. The vending machine in the 2700 building was supposed to only dispense water, however, some changes have been made along Administration and now carbonated drinks are also being sold. Mr. Webster states that his Maintenance Department is very short staffed. According to Mr. Webster since soft drinks were included in the vending machine, his staff has seen an increase of spills and soda stains in the building. Soft drinks are allowed in the 3100 and 3200 buildings because it is concrete walkways. The gymnasium is also another area of concerned as a new vending machines was also installed there. Maintenance has found trash behind the bleachers and several soda spills on the gym floor. Mr. Webster understands that ASG receives a commission of the sales but at the end of the

day, we must keep our facilities nice and clean for our students, staff and our community.

Dr. Johnson stated that the Administration is not oppose to providing soft drinks and a snack machine in certain areas but some type of remedy needs to be in place to keep the areas clean. Dr. Johnson invites the ASG to come up with solutions such as a cleanup schedule or assigning a student to upkeep the area where the burden does not fall on the Maintenance staff. If a set plan is not put forth, the machines will be removed.

WHEREAS, the Student Senate for California Community Colleges (SSCCC) is the recognized student body for the two million, one hundred thousand students of the California community college system;

WHEREAS, an estimated sixty thousand ¹ of the SSCCC constituents are recipients of the Deferred Action for Childhood Arrivals;

WHEREAS, recipients (DREAMers) came to America as children, and most do not know another country but the United States and have established jobs, families, and lives here; WHEREAS, the deportation of these student DREAMers would result in a massive negative impact in the lives of DREAMers and the country at large, by not allowing for equal educational and professional opportunities for those who are citizens at heart; therefore be it RESOLVED, that the SSCCC adopt formal support for DREAMers, and urge ASOs to express their support in writing; and be it further

RESOLVED, that the SSCCC urge the California Legislature, the Board of Governors for California Community Colleges, and the governing bodies of community college districts to pass legislation supporting DREAMers.
