Visitor, VP Lau suggested extending an invitation to all Campus Clubs to participate in the tournament. An email will be drafted this week. Senator Limon will be visiting Academi Awards in regards to the trophy.

M/S/C (Gil/Rodriguez) to suspend the rules of the day at 1:16 p.m. and allow VP Lau to speak on the College Center Resolution Update (Unfinished Business, Item ii).

VP Lau addressed the Senate regarding the College Center resolution which was spearheaded by a couple IVC students and ASG supporting the item. VP Lau presented a PowerPoint presentation as follow:

Capital projects — next 5 years funded with bond money State Contribution Academic Buildings — modernization \$7,255,000 Auto Body facility — modernization \$10,000,000 O Deferred maintenance projects \$11,003,000 Nursing Building — modernization \$2,300,000 Bookstore \$1,200,000 Total \$31,718,000 Projects not funded with Bond money: Removal of the 2000 Building and Remodeling of the 2400 and 2500 Buildings. Fund 20 (Construction) will be used. Estimated cost: \$200,000

Suspend the Rules of the Day

VP Lau stated that his job is to ensure there is planning and financing for every project on campus. The College will be selling \$32M in bonds but the college must pay that back. Bonds can be sold every five years but Capital Planning is done and this is where the college plans the upcoming projects for the next five years. He stated that the modernization of academic buildings such as the 800, 300 and 200 must be done as the college will be covering 50% of the cost and the state will be contributing the remaining 50%. The automotive facility has been in the modernization list about 11 years ago and has priority over any other building especially with our Board of Trustees members. The college's financial status has been in recession and the automotive facility keeps being pushed down the priority list.

VP Lau stated that the college has a 7% growth which means the college will be receiving revenue.

VP Lau also stated that I.T. has become very expensive. White board cost more than a chalkboard. All the technology in the classrooms must be kept up-to-date and it costs money to do so. The IVC Bookstore is also another building that needs to be taken care of and has a high priority.

VP Lau is requesting the ASG's support with the following:

- o Need to collect additional data (i.e., overcrowd? Where, what time of the day, etc.). If possible, a year-round data.
- o What would the new building be located? Or is ASG considering in remodeling the current college center?
- o Is there a design?
- o How does ASG plan to fund this project?

VP Lau suggests for ASG to get a taskforce together and collect the above data. Once that data is collected, he suggests bringing it up to the Administration for review.

Due to the lack of time, VP Lau was thanked and excused at 1:42 p.m.

M/S/C (Gil/Caloca) to resume the rules of the day at 1:42 p.m.

At this time the Cultural Commission provided the floor to Mr. Guillermo Salgado.

Mr. Salgado introduced himself to the Senate. Mr. Salgado has a small business in the valley where he has hosted several entertainment shows such as comedians. Mr. Salgado would like to bring a music festival on campus.

Dean Torres suggests for both Co-Chairs to meet with Mr. Salgado in the next week or so to come up with a plan. Ms. Cardoza suggested reviewing their bylaws to see if this events are possible as they are elected officials and might not be able to generate profit.

The ASG thanked and excused Mr. Salgado at 1:49 p.m.
