- ICCD Information Protection Operational Procedure manual Jeff Enz, Chief Technology Officer, presented information relating to the Information Protection policy "established in an effort to protect the confidentiality, integrity, and availability of personally identifiable information, trade secrets, intellectual property, and any other sensitive data held by the organization."
- 2. Classroom Technology Xochitl Tirado. Jeff Enz and Elizabeth Kemp presented information on behalf of Ms. Tirado relating to the 4000 bldg, a teaching lab in which new instructional technologies can be tested prior to campus-wide distribution.  - WHEREAS, the 2019-2022 Student Equity Plan is due to the Chancellor's Office on or before June 30, 2019, and
 - WHEREAS, California Community Colleges are required by the Chancellor's Office to develop a three-year student equity plan, and
 - WHEREAS, the intent of the student equity plan is to close achievement gaps in access and success in underrepresented student groups, and
 - WHEREAS, a draft of the Student Equity Plan 2019-2022 was presented to the Academic Senate on May 15, 2019;
 - NOW, THEREFORE, BE IT RESOLVED, that the Academic Senate approves the 2019-2022 Student Equity Plan.
- Approval of AP 3435 Discrimination and Harassment Complaints and Investigations (M/S/C Epps/Soto)
 It was noted that these Administrative Procedures meet the current need to protect the District.
- 4. Librarian Hiring Freeze and Library Staffing in the IVC Library (M/S/C Zazueta/Orfanos Woo) [Senate Resolution 2018-19.03]

WHEREAS, the current reference librarian is retiring effective 27 June 2019, and WHEREAS, the replacement hire of a new full-time librarian has been frozen by the Superintendent/President for budgetary reasons, and

- WHEREAS, Ed Code 78103 mandates the presence of academic personnel in the Library ("shall be under the supervision of academic personnel") at all times the Library is open, and
- WHEREAS, the departure of the reference librarian will leave the IVC Library with one fulltime and one part-librarian who will struggle to maintain the current Library hours (57 hours/week during the regular semester); and

WHEREAS, one of the Institutional Student Learning Outcomes is Information Literacy; and WHEREAS, the ICCD governing board has affirmed Information Literacy as an ISLO;

THEREFORE, BE IT RESOLVED that the IVC Academic Senate requests the District to hire a replacement librarian in time for the beginning of the Fall semester 2019.

Comments were made in support of the resolution. President Lofgren will read the resolution to the governing board at their 19 June 2019 meeting. Mary Jo Wainwright noted that the CHRO disagrees with the faculty's interpretation of the term "academic personnel."
