B. Visitor's Comments

Dr. Hope Davis recognized the new AA-T degree in American Sign Language and encouraged the college to consider developing degree/certificate programs specifically for special populations such as blind students.

Mary Jo Wainwright shared her concern that the new Director of Student Development and Activities is only a classified manager, not an educational administrator but according to Dr. Johnson would deal with student complaints against faculty. The handling of student complaints and discipline are an Academic Senate issue, but any complaint against faculty members becomes a union issue. Student complaints and discipline should stay under the Dean of Student Affairs and Enrollment Services, an educational administrator.

D. Treasurer's Report
