ADMINISTRATION OF JUSTICE

I. Program Description

The Administration of Justice program is designed for the potential student to begin with the 100 level courses, building a foundation of knowledge of the justice field. After establishing that knowledge base, the student can proceed in a variety of directions to enhance their specific knowledge and career goals. The program offers a general Administration of Justice degree, with no specific emphasis, allowing the students to be able to fine-tune their career choices at a later date. The program also offers the Administration of Justice degree with a choice of Specializations and/or Certificates that can provide the student with more specific knowledge and training, designed to provide a more specific direction and career path for the student. These Specializations are in the areas of Criminal Justice, Correctional Science, and Law Enforcement. In the future, we hope to be able to offer the student a specialization in Homeland Security as well as Crime Scene investigation and Forensics.

The new CTE buildings have provided state of the art classrooms and a physical way to ensure public safety programs are adjacent to each other as well as more easily recognized.

The new CTE buildings have also facilitated the location of the Administration of Justice program within the same building as other public safety programs. However, as the CSI and other public safety programs grow and the pending addition of a POST Level 1, there will be additional issues with the limited classroom space.

There are concerns with non-public safety and non-CTE events being held in 3200 with prior planning and arrangements with the public safety faculty to ensure equipment and supplies are secured safely.

Strengths The support of the Law Enforcement and Correctional Agencies throughout the county is the #1 strength. New facility has improved perceptions. Currently expanding online courses to increase access.	<i>Weaknesses</i> Limited classroom space due to multiple public safety programs.
Opportunities The program is staffed primarily with part- time faculty and 1 full-time faculty. When a POST Level 1 is created, there will be a need for additional FT faculty who will also help promote and advance this program.	Threats Identifying the student need/preference for the course offerings and correlating that to the availability of the part-time faculty is ever-challenging.

The Administration of Justice program has strong indicators across all evaluation components. Labor market demand is strong; State core measurements are at or above state levels; Fill rates are strong; graduation rates are also strong; and productivity is high
