C. New Discussion

a. 2015-16 Class Schedule Update

- ✓ D. Gilison announced that the schedule is done. Has been submitted to the instruction office.
- ✓ He will be working on faculty selection next.
- ✓ He mentioned that there were minor issues with new time block schedule.
- ✓ Class selection for all of next academic year are supposed to be done before Thanksgiving break.

- ✓ All FT/PT need to get training.
- ✓ SPOL data needs to be in this semester.
- ✓ If you have SLOs that that have to be submitted this semester you need to have the training now otherwise you can wait until spring to do the training.

c. Expanding Your Horizons (April 25th)

- ✓ D. Gilison introduced Lisa Rajigah-Perske, Conference Coordinator.
- ✓ Expanding Your Horizons conference will be April 25th 8:00-3:00 pm on campus.
- ✓ Their mission: Inspiring girls to recognize their potential and pursue opportunities in science, technology, engineering and mathematics (STEM).

d. Agriculture Program Update - P. Pauley

- ✓ Pat reported two courses in curricUNET are in alignment with CID curriculum.
- ✓ D. Gilison stated that a handful of programs are supposed to be updated for transfer model curriculum so they match up with approved curriculum from the Chancellors office. Used to be called TMC and now they're called ADT (Associate Degree Transfer).
- ✓ P. Pauley stated that there are three transfer model curriculum templates for AG (business, animal science, plant science).
- ✓ On October 9th IVC campus had Career Day. At the last AG advisory meeting members present agreed that it would be great to have Ag companies out there so that students can see what job opportunities are out there. D. Gilison asked P. Pauley for an update on Career Day.
- ✓ P. Pauley stated that he did not attend but that they (Ag Advisory) had discussed having their own career awareness event in spring.

e. Inactivation of CHEM 204 and CHEM 206 – J. Fisher

- ✓ Organic chemistry classes have not been taught in over three years.
- ✓ Administration would like them off the books. J. Fisher would like to keep. Only problem is Chancellors office feels we are not in compliance. If they're on the books then SLOs need to be assessed.
- ✓ J. Fisher gave a brief overview on schools that offer organic chemistry and some that don't. If we could offer these two classes then we have a chance TMC models for California. TMC model basically guarantees a student a spot at the UC state schools.
- ✓ J. Fisher feels we have the demand/FTES/students/sections we just don't have the instructor.

f. Chem/STEM Club Career Activities - A. Benedicto
