✓ Motion was made to approve update prerequisites for BIOL 100, BIOL 120, BIOL 122, BIOL 150, BIOL 180, BIOL 182, BIOL 200, BIOL 202, BIOL 204, BIOL 206, BIOL 220 and CHEM 100, CHEM 160. Prerequisite changes are in response to AB705. Community colleges are no longer allowed to teach courses one level below college level.
